Sea Tow will not be held liable for invoices or bills of any other towing company. Sea Tow must be used where its coverage is available. Members assume all risk of towing and all other services required, and hereby hold Sea Tow harmless in all such respects, in all instances other than gross negligence. In the event of any emergency, threat of or actual injury to persons aboard ship or any occurrence that threatens the safety of passengers or vessel, member MUST immediately contact the U.S. Coast Guard and request emergency assistance. Service will vary by area and by season, and are subject to the discretion of the provider in light of the circumstances then present.
